CONTINUING PUBLIC HEALTH SAFETY RESTRICTIONS IN THE DISTRICT OF COLUMBIA HAD A SIGNIFICANT IMPACT ON THE NUMBER AND TYPES OF IN-PERSON EVENTS THAT WERE ALLOWED TO BE HELD IN THE VISITOR CENTER THROUGH THE
